#### **Data We Collect**

We take appropriate technical and organizational measures to protect your data, including:

#### **Data Retention**

We retain client records, including personal information, trading history, and communications, for at least three (3) years after the business relationship ends, as required by law. Data will be securely deleted when no longer required.

Your data may be processed inside or outside Mauritius in compliance with the Mauritius Data Protection Act 2017 and, where applicable, international standards such as the GDPR.
